#### **Broad Impact Assessment**

- Based on VAT Law assess potential VAT impact on business (on "as is/what if" basis).
- Sift impact areas into areas of opportunity and threats.
- Identify possible Scenarios under which above identified Opportunities / threats could be maximized or minimized, as the case be.
- Identify whether need is felt for Representation to VAT policymakers to minimize impact areas.



#### **Implementation Assistance**

- Short-list realistic Scenarios that could be implemented for VAT preparedness
- Custom-design changes that need to occur in ERP, Internal Controls, Accounting
- Make relevant changes in Supply Chain & Identify changes in documentation, processes and policies to meet VAT requirements.
